I will be as brief and direct as possible.

FACT:

Members of the group "our Posterity", named in the Constitution to receive its benefits, are losing their lives as you read this communication.

YOU have a constitutional and moral duty to stop this, immediately.

YOU have sworn or affirmed to support and/or defend the Constitution of the United States and are required to PROTECT OUR POSTERITY.

FOR YOUR REFERENCE:

The Statement of Purpose of the United States Constitution:

We, the People of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defense, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America.

As you can see, the reason the Constitution was ordained and established for the United States of America was NOT just to secure the “Blessings of Liberty” to “ourselves” but to secure them, at least equally, if not even more so, to “our Posterity”.

“our Posterity” is all our descendants until the end of time. It is the vision of, and, at minimum, includes, our unborn descendants, far into the future. It is an expression of the concept of doing things for our descendants to come, to the furthest generation, who have not yet been born.

The Constitution of the United States names two groups as the object of all it and this nation are to provide. Currently, members of the first group named, “ourselves”, are denying all rights, benefits, blessings and protection to members of the second group named, “our Posterity”. You, as a member of that first group, and, as an official who has sworn or affirmed to support and/or defend the Constitution of the United States, cannot honor that oath or affirmation and continue to permit the denial of these protections, blessings, benefits and rights, which are the object of the Constitution, for members of the second group named, right alongside us, and still remain qualified to hold office.

As you can plainly see, the destruction, elimination, extermination of any member of the second group named in the Constitution to receive its benefits, “our Posterity”, without due process of the law, is no more permissible than would be the destruction, elimination, extermination of any member of the first group named —namely: “ourselves”.

From this information, I suspect you understand the truth of these facts and understand your need to treat “our Posterity” as “ourselves”. Understanding that “our Posterity” are being denied these benefits, rights, blessings and protections when they are irreversibly destroyed through the process known as *abortion*, you will recognize your responsibility to, immediately, cause the halting of abortions that destroy any one of “our Posterity”, the second group named, right alongside “ourselves”.

Therefore, at minimum, you must, immediately. prohibit any of "our Posterity", any of our unborn descendants in the womb, from being destroyed in the womb through the procedure know as *abortion*.

Failure to do so would be to abandon your oath of office, which is your contract with the good people of the United States, and, if you choose to break your contract with us, you will no longer hold the office or the authority attached to that office, and will, therefore, be required to vacate any and all governmental property owned by the good people of the nation, state or community.

We are, therefore, compelled to demand that you do your duty and act immediately to recognize, honor and defend "our Posterity", our unborn descendants, and if you fail to do so, you will be subject to the same penalties, in law, including criminal prosecution, just as if this were one of "ourselves" being destroyed without due process of the law.

So, call for, and act to institute, an immediate moratorium, a halting, of all abortions of "our Posterity", who are our young descendants in the womb, today.

We, and the Constitution, require immediate action to halt the extermination of "our Posterity" and we require that you notify us of that action, no later than five (5) days from receipt or knowledge of this information.

Further, anyone delaying this information from getting to the designated recipient will be held accountable for any deaths or injuries that occur as a result.
